Attachment A: Value/ Consideration

- 238,355,016 were acquired by Bioton S.A. for a total of A\$22,119,345.52 following a takeover offer, on 20 March 2006.
- 14,845,276 were acquired by Bioton S.A. for a total of A\$233,070.88 plus 298,358 Bioton Shares following a takeover offer, on 20 March 2006. The issue price for each Bioton Share is 9.63 Polish zlotys.
- 100,692,832 were acquired by Bioton S.A. for A\$7,551,962.40 (which is equivalent to A\$0.075 per share) plus the subscription by Scitech Genetics Pte Ltd of 2,020,579 Bioton Shares, valued at approximately 9.625 Polish zlotys per Bioton Share as at the time of execution of the share purchase and subscription agreement on 27 October 2005 (which was the average of minimum and maximum of market price of Bioton S.A. shares traded on the Warsaw Stock Exchange).
- 5,000,000 were transferred to Bioton S.A by Scitech Genetics Pte Ltd on 20 February 2006 for A\$350,000 in accordance with an arrangement between Bioton S.A. and Scitech Genetics Pte Ltd on 18 March 2005 (payment was made on 23 March 2005).
