The effect of the change in functional currency of the Company has been accounted for prospectively in the interim financial information of the Company. Due to the change in functional currency of the Company, the presentation currency of the financial statements of the Company has been changed from Singapore dollars to the United States dollars.

Comparatives of the Group are presented in United States dollars due to a change in functional currency from Singapore dollars to United States dollars during the period. As at 31 December 2006, assets and liabilities are translated from Singapore dollars to United States dollars at exchange rate ruling at that date. Income and expense items for the six months ended 31 December 2006 are translated at the average rate for the period. The resultant exchange differences are recognised directly in equity as at 31 December 2006.
