As at 31 December 2006, assets and liabilities are translated from Singapore dollars to United States dollars at exchange rate ruling at that date. Income and expense items for the six months ended 31 December 2006 are translated at the average rate for the period. The resultant exchange differences are recognised directly in equity as at 31 December 2006.
